Georgia — positive developments despite instability

Despite the problems Georgia faced in 2008, activities to enhance good governance on minorities through support to government institutions as well as the activities in the minority regions of Georgia in the Samtskhe-Javakheti and Kvemo Kartli were continued.

The “Denmark’s Caucasus Programme 2005-07”, extended until June 2008, and dealing with government structures was successfully concluded.

Also the programme entitled “Enhancing Minority Governance and Enhancing Civil Society in Minority Regions of Georgia 2007” funded by the Royal Norwegian Ministry for Foreign Affairs (also extended until June 2008) was concluded. This programme has been supporting capacity building of regional national minority organizations, in the predominantly Armenian region of Javakheti (part of the Samtskhe-Javakheti province) and the multiethnic region of Kvemo Kartli, with emphasis on the Tsalka district inhabited by Armenians, Georgians, Azeris and Greeks. A follow-on project in 2009, aiming at making sustainable the two established networks of civil society stakeholders, the

Javakheti Citizens’ Forum (JCF) and the Tsalka Citizens’ Forum (TCF) will aim at phasing out ECMI’s direct engagement with JCF. ECMI will continue to support JCF financially, but without the active involvement as in previous years, while it is envisaged that JCF — with its developed organizational structures and administrative capacity — will be able to secure funding from other donors from 2010 and beyond. TCF, which started its consolidation later, is also on its way towards sustainability. It is envisaged that TCF can become partially sustainable in 2009, while direct financial support to elementary activities, such as the running of a resource centre, core staff etc. will still be required beyond that point.

The new “Denmark’s Caucasus Programme 2008 – 2009, Enhancing good governance, human rights and the rule of law in Georgia” implemented by the Council of Europe and funded by the Royal Danish Ministry of Foreign Affairs, is supporting democratization in Georgia with a focus on the judiciary, the Public Defender’s Office and institutions responsible for minority issues. Within this programme ECMI acts as a

sub-implementing partner, responsible for the component on minority issues (see also ECMI newsletter Vol.6/issue 2).

A Memorandum of Cooperation was signed in June between the Council of National Minorities, set up by the Public Defender of Georgia and ECMI in December 2005, and the Council of Tolerance and Integration under the President’s Administration in order to further develop and institutionalize interactions between the government and national minority representatives.

Commitments to the Council of Europe

In 2008, the political turbulence significantly impacted on the implementation of the sensitive issues related to programming on national minorities. While the government priorities shifted to crisis management, a few positive developments were still seen.

In April, the former head of board of the Georgian State TV channel, Mrs. Tamar Kintsurashvili, was appointed as Advisor to the President on Minority and Civil Integration Issues. After the parliamentary elections Mrs. Elena Tevdoradze, who formerly had held the post as Chairperson of the Parliamentary Committee for Human Rights and Civil Integration was appointed as Deputy Minister for Reintegration with the mandate of establishing a Department for Minority

Issues. The appointment of two senior officials with previous experience in the field of minorities is a positive sign that the government increasingly pays attention to this policy area. The minority department in the Reintegration Ministry was eventually formed in October, with three regional representations in minority regions. ECMI envisages a number of new activities to be conducted in 2009 to support the functioning and development of the minority department.

Minority legislation

Georgia has yet to fulfil two missing commitments to the Council of Europe, namely the signing and ratification of the *European Charter for Regional or Minority Languages (ECRML)* and the *Law on Minorities*. Both are considered highly controversial by the government. However, the central authorities seem now to be close to commit to the Language Charter; at least a specific reference to the Charter has been incorporated into the Government's Strategy for Protection and Integration of Minorities.

On the Law on Minorities, the Government is of the opinion that there is no need for a separate law, as minority related legislation is or should be covered by the general legislative framework, including in the fields of education, culture, economic activities, penalty codes, etc. There are also concerns that a separate law risks being in contradiction with other legislation. It has been discussed recently whether this commitment could be modified, so as to ensure minority protection rather by a review of and amendments to already existing legislation. Such considerations are likely to result in policy action in 2009.

Repatriation of the Meskhetian Turks

According to the provisions of the law, deported persons or their descendants, who wish to repatriate to Georgia, can apply for repatriation status only in 2008. Perhaps due to government priorities related to the political turbulence and the outbreak of war in 2008, the political climate in Georgia did not accommodate a process that could clarify and streamline policies with regard to the repatriation process. The year saw hardly any progress in clarifying the ambiguous provisions of the law. As a result, the Meskhetians were left with little clarity as to their rights and duties in relation to submission of applications. At the same time, the responsible Georgian authorities, i.e. the Ministry for Refugees and Accommodation and the Ministry of Foreign Affairs did not ensure that application material was available in the English language (as required by the law) in consulates abroad until sometime in early

March, and Meskhetians in several countries were complaining that they were unable to find properly informed staff there. Moreover, it was not until July that some details with regard to health certificates had been clarified by the Georgian authorities, hence impacting negatively on the possibility for Meskhetians to submit their documents.

To provide potential applicants with proper information about their possibilities for applying, and the practicalities related to the application process, ECMI in a separate intervention implemented an awareness raising project for Meskhetian applicants in Azerbaijan in the final months of 2008. Carried out in collaboration with the International Organization for Migration (IOM) through funding from the Council of Europe, a training-of-trainers workshop took place in Baku in November, followed by a sequence of information meetings.

On 29 December, just a few days before the expiration of the originally set deadline for submission of applications, the parliament of Georgia passed an amendment to the law on repatriation that extended the deadline for submission of applications until 1 July 2009. The extension will give involved actors a much needed possibility to enhance work on informing and supporting potential applicants in submitting their applications. ECMI will seek to continue activities to this end in this period.

Council of Europe conventions

Having ratified the Council of Europe Framework Convention for the Protection of National Minorities in 2005, the convention entered into force in Georgia on 1 April 2006. A state report was submitted to the Council of Europe in July 2007, and was according to the established monitoring practice to be followed by a visit of the Advisory Committee of the Framework Convention soon after. Due to the political turbulence at the domestic scene, the state visit was postponed several times. However, the mission finally took place on 8-13 December with the participation of three members of the Advisory Committee. Along with the Government of Georgia, ECMI played a key role in organizing the visit. It included a thorough round of consultations with most minority organizations and relevant community structures in the country and regions of Javakheti, Kvemo Kartli and Shida Kartli. The findings of the Advisory Committee will lead to an Opinion on Georgia to be published in spring 2009. Following the visit of the Advisory Committee, it is envisaged that ECMI in 2009 can conduct a number of trainings and other activities to support the

implementation of the FCNM.

ECMI will also support the implementation of the ECRML, the Law on Repatriation and the yet unfulfilled commitments and obligations as part of the minority component of Denmark's Caucasus Programme 2008-09. A number of trainings, seminars, conferences and workshops are planned to this end.

Research and Documentation

In past interventions, research and documentation on groups or issues have been instrumental in directing governmental and/or international attention to specific problems. A comprehensive field research among the small but disadvantaged Romani communities in Georgia (http://www.ecmi.de/download/working_paper_39.pdf) has provided basic insight in the plight of the community, and is hoped to lead to policy action by government and NGO actors.

ECMI also continued research on the effect of educational reform on national minorities, and a study on the development of institutions responsible for minority issues since the Rose Revolution in 2003. Both reports are expected for publication in early 2009.

In addition, two studies are in progress in relation to the expected signing and ratification of the European Charter for Regional or Minority Languages; a paper on language issues in Javakheti and Kvemo Kartli and a paper on regional languages (Megrelian, Svan and Laz). These papers will be presented to inform the debate between government and minority/regional stakeholders, envisaged for 2009.

Moreover, field studies in the Georgian breakaway region of Abkhazia has led to the compilation of a book on the inter-ethnic situation in that territory. The book with the title "*Under Siege: Inter-Ethnic Relations in Abkhazia*" by Tom Trier, Hedvig Lohm and David Szakonyi will be published by Hurst & Co. (Publishers) LTD in Spring 2009.

Finally, ECMI continued its work on a larger research project that will lead to the publication of a handbook on Georgia's ethnic groups under the title: *Georgia – An Ethno-Political Handbook*, by Tom Trier & George Tarkhan-Mouravi, expected for publication in 2009 by the British publisher Bennett & Bloom. Georgian and Russian versions of the book are being prepared in parallel, thanks to a grant from the Swiss Embassy in Georgia. The eventful year of 2008 necessitated a significant number of revisions, which affected the completion of the manuscript.

Creating an Ethnopolitical Map of Kosovo

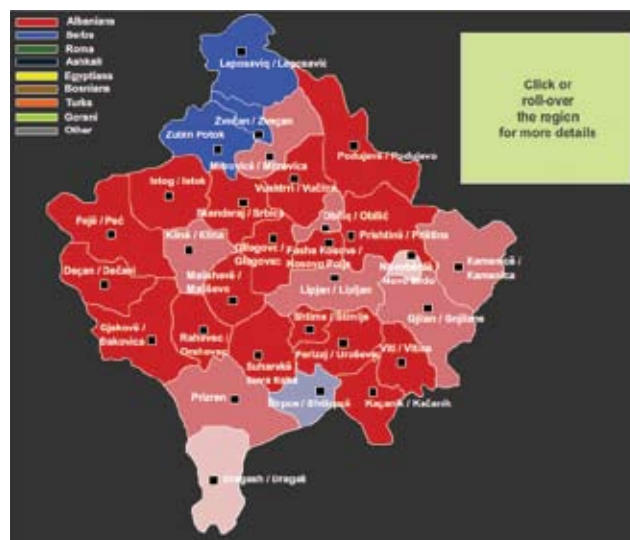
The issues surrounding communities in Kosovo are highly complex and can be very confusing to both outsiders and those more familiar with the local situation. At the same time, accommodating communities in Kosovo's socio-political system is vital to creating a workable society. Unfortunately, information on the different communities is often incomplete, inaccurate or unavailable, making it difficult for those engaged in government, international organisations or civil society to have a clear idea of the situation of communities in Kosovo today.

ECMI Kosovo has aimed to redress this situation, by creating an Ethnopolitical Map of Kosovo, providing the first comprehensive and easily accessible overview of the communities living in Kosovo and the issues they face. The Map is a dynamic project that can be updated at any time with external input always welcome. ECMI Kosovo will be responsible for keeping the map up to date, and any comments or additional relevant information can be sent to ECMI Kosovo and will be included in the map after a quality check.

In creating the Ethnopolitical Map ECMI Kosovo used its extensive expertise, contacts and experience with communities

in Kosovo to compile all available information into one comprehensive database.

The main feature of the project is an interactive map of Kosovo which, through colour schemes, provides a general idea of where the different communities in Kosovo live. This interactive map is linked to information on the issues communities face both on the national and local level. With regard to the national level, the project covers areas such as: the system of political representation of communities in Kosovo, the legislative framework for the protection of communities, all important institutions for the protection of communities, the main issues facing communities in Kosovo today and short overviews of all communities in Kosovo. Moreover, it provides links to relevant documents and websites and the contact details of relevant organisations. On the local level, each municipality includes a short overview of the current situation facing communities in that particular region. These overviews include information on a variety of topics such as demographics, health care, security, economics, political representation,



security and the contact details of relevant organisations and government officials. To acquire this information ECMI Kosovo hired a team of field researchers who have consulted multiple sources, both governmental and non-governmental, within each municipality.

Thus, the Ethnopolitical Map covers community issues from the local and national perspective and includes the views of civil society, the international community and the Kosovo government to offer a comprehensive and easily accessible database on communities in Kosovo. This project thus addresses the current lack of information on communities and by publicising the issues faced by Kosovo's many communities also makes a real contribution to the tackling these problems.

POLITICAL PARTICIPATION

The activities of the political participation program focused on the research of minority representation in state institutions. The emphasis has been on the representational effects of different electoral systems. Alternative formulas for proportional representation, single member districts rules, and minority reserved seats provisions lead to different outcomes in terms of identity of minority representatives and their responsiveness and accountability to minority constituencies. ECMI engaged in efforts to collect detailed data on background characteristics and legislative behaviour of minority representatives across a number of national parliaments. Large datasets have already been con-

structed and updated for the Romanian and Moldovan parliaments. These datasets include detailed information on minority deputies' draft law initiatives, sponsorship of parliamentary resolutions, and other types of legislative output. Similar data sets have also been developed for Bulgaria and Ukraine.

Minority representation in the executive government has also been of interest to ECMI. Cabinet level representation is an important indicator of minority inclusion in the national level executive politics. The information on which ethnic minority members are included in the highest ranks of executive government and what policy jurisdictions (cabinet portfolios) they control when in government has been collected for Moldova. This data provides a basis for examining the feasibility of using

cabinet representation as an indicator for minority inclusion in executive government on a cross-national level.

The findings of this ongoing research have been published in the ECMI working paper series (www.ecmi.de/rubrik/58/working+papers). These results and anticipated new findings will allow to better understand what the implications of adopting different electoral formulas for guaranteeing minorities' descriptive representation (whether minorities are actually represented by members of their communities) and substantive representation (whether policy concerns of minorities are addressed by their representatives) are.

Two issue briefs and a cumulative working paper as well as an extensive resource database on the issue were the concrete outputs of the desk research (www.ecmiserver.de/eeo/).

The publications are shedding light on the concept of economic exclusion, as well as on the most relevant legal frameworks that try to tackle economic exclusion related to ethnic minorities. The relationship to the more codified principle of non-discrimination related to minority questions are taken into account as a way to address the question of exclusion.

The necessity to apply the concept of social/economic exclusion to old minorities and to new migrant ones is stressed. However, this shift in group emphasis does not mean that the concept of economic exclusion, as originally developed in research on labour migration into western European welfare states, has to

be abandoned or re-formulated.

The measurement of the level of exclusion to verify its existence and its forms through establishing of viable indicators proceeds from two perspective – the constant economic growth (EU) and sustainable development (UNDP). Although not mutually exclusive, they apply different set of variables and end with different results.

Bringing together the conceptual frame and the indicators frame, the cumulative working paper proposes an integrated approach to minority economic inclusion,

becoming a separate focus of attention for democratic minority governance, particularly at local, decentralized levels.

Finally, a separate programme website (www.ecmiserver.de/eeo/) that includes an extensive annotated bibliography on the topic of economic exclusion was created.

Language and Culture Diversity Programme

The recently published Issue Brief “Language Loss and the Ethnic Identity of Minorities” (www.ecmi.de/download/brief_18.pdf) presents various entry points to the discussion of the relation between language and culture diversity. Although the European legislative framework provides for the protection of linguistic minorities with increasing efficiency, the protection of their language rights remains a matter for individual member states.

Despite a growing awareness of the need to protect the cultural rights of ethnic minorities that can be observed in the academic discourse as well as in legal aspects, many states are still reluctant to recognize minorities that do not speak a native minority language. Therefore, legal definitions need to consider the fact that many ethnic minorities have lost their language, often as a consequence of assimilative state policies and thus need protection on the basis of other identity markers.

Such a legal framework would discourage the states from offering incentives that will make minorities to abandon

their language and not to regard minorities and their visibility as an asset. Instead it could encourage the states to implement policies towards European standards of cultural and linguistic diversity.

This research supports the hypothesis that after a minority has lost its distinctive language, it is still eligible for legal protection of its culture on the basis of its self-assignment, and the will to maintain an identity that distinguishes it from the majority population and other ethnic or regional groups living in a state.

The research on language loss and its effect on ethnic identity, was put into practice at the Annual Meeting of the Working Group of German Minorities of FUEN (Federal Union of European Nationalities) in **Kosice**, Slovakia. The German minorities are the largest national minorities in Europe after the Russians. The main theme of the meeting was language maintenance and transmission as well as problems concerning the relation between state language and minority languages.

Introduced by Dr Christoph Bergner, Parliamentary State Secretary, the topic was vividly discussed among German

minority representatives from Central and Eastern Europe. The ECMI presenter, Ulrike Schmidt, proposed a number of different issues and questions to be taken up in the discussion on the situation of the German language in the areas of education and media in the participants’ respective countries. New Network Co-operation

Language and Culture Diversity Programme has joined a new network: Network to Promote Linguistic Diversity, established by several European minority language boards. The network is working towards improved policy and language planning for minority languages in Europe.

Regional activities

In 2008 ECMI concluded two regional cooperation agreements, one with the University of Flensburg and one with the University of South Denmark (SDU), Faculty of Social Sciences and in particular with the Department of Border Region Studies, a former Institute of Border Region Studies (IFG). The cooperation agreements were immediately effectuated through teaching seminars, conference participation and joint publication to appear in 2009.

“*Crossing National Boundaries – Regional University cooperation in Europe*” was a conference organized by the University of Flensburg. ECMI chaired and contributed to the session on “Border Region Universities and European Studies”.

A conference organized by SDU-IFG on “The Roots of Civil War and Conflicts and their Influence on Transformations of State- and Civil Society Institutions” at the SDU in Sønderborg included two ECMI contributions, one by Tim Dertwinkel on “Ethnic Cleansing During Civil War: A Disaggregated Study of Bosnia 1992-1995” and one by Tom Trier on “Ethnic Conflict in Georgia: Perspectives

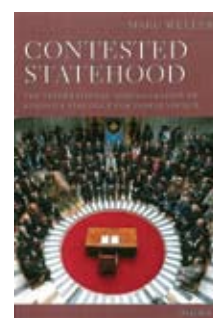
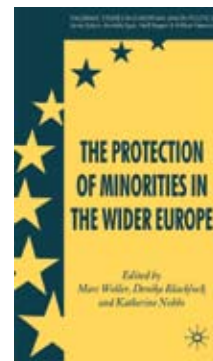
